FIRM PROFILE

Litigation

At both the trial and appellate levels, Andrew T. Traylor, P.A. is 100 percent engaged in

Federal and State court litigation. The firm's attorneys are in court on a regular basis, conducting trials (both jury and non-jury), motions, evidentiary hearings and a wide variety of other litigation hearings. When we are not in court, we are routinely investigating and pursuing cases for our clients. The following areas of the firm's litigation practice recur most frequently:

General Civil Litigation - To provide the most effective service to clients, the firm takes a dynamic approach to litigation management. We often initially hold a strategy meeting with the client to discuss objectives, strategies, budgeting, and fee arrangements. This attorney/client partnership often develops a strategy which will achieve the best result at the lowest cost to the client. Often the course chosen may include alternative dispute resolution (ADR) methods, creative settlement approaches or trial.

Aviation Litigation - The firm handles aviation accidents around the world. Over time the firm has muscled its way into this very competitive field with innovative ideas and arguments. The firm was the first firm to apply the Multi-Party Multi-Forum Trial Jurisdiction Act of 2002 (the "MMTJA"), 28 USC §1369, to an aviation accident and argued portions of that litigation all the way to the United States Supreme Court. The application of the MMTJA to aviation accidents will revolutionize aviation litigation in the United States.

International Litigation - As a component of aviation litigation, the firm is often immersed in litigations involving other legal systems from around the world and in the litigation of international treaties such as the Warsaw Convention, the Montreal Convention and the Hague Convention.

Commercial Litigation - The firm represents many clients whose commercial disputes culminate in civil litigation. Typical cases involve suits over breaches of contract, class actions, employment contracts and disputes, violations of agreements involving proprietary rights, complex landlord and tenant issues, real property, title and survey issues, foreclosure, negotiable instruments, commercial instruments, employment contracts and disputes.

Catastrophic Personal Injury Litigation - Andrew T. Traylor, P.A. has served as counsel in many personal injury lawsuits including wrongful death and survival actions arising from deaths by aviation accidents, drownings, truck and automobile accident, and nursing home malpractice. Some of these actions have involved theories of products liability while others have been based on intentional activity or negligence.

Insurance Litigation - The firm represents policy holders whose insurance company refuses to pay. In some instances, the firm not only seeks compensatory, but may ask for punitive damages as well.

Construction Litigation - The firm has extensive experience in representing developers, builders, engineers, subcontractors and owners in construction matters, such as failure to fulfill contractual obligations, allegations of defects, and disagreements over financial responsibility.

Condominium Litigation - The firm has extensive experience with condominium operation and litigation. Our representation has been of both condominium associations and unit owners in related disputes and has involved numerous matters including reserves, maintenance, notices, meeting, elections, property reviews, management companies and the like.

Real Estate Related Litigation - In instances where litigation of real estate related problems is appropriate, the firm has furnished its trial services covering a broad spectrum of real estate problems. These have included foreclosure, construction disputes in arbitration and the courts, matters relating to construction liens, professional negligence involving design professionals, contract and commercial leasing disputes, lender liability cases, brokerage disagreements, and title insurance concerns.

Alternative Dispute Resolution

ADR- It is important for the client to understand that a case may best be resolved either prior to litigation or, if in litigation, prior to trial. Although the firm is fully equipped to take difficult cases to trial, sometimes the best results are achieved by obtaining favorable terms of settlement through negotiation, mediation or arbitration.

Business-Related Issues

Corporate and Business Services - The firm provides general business representation, such as assisting in the formation of corporations, purchase and sale of corporate stock or commercial assets, negotiation of employment agreement, non-compete agreement and confidentiality agreements.

We assist in organizing corporations, partnerships, limited liability companies, sole proprietorships, professional corporations, and other business enterprises. This usually includes the preparation of all necessary documentation to formalize the entity's existence. When tax advice is necessary, we have long established relationships with accountants or tax attorneys to assist our clients.
