18 THIS MATTER came before the Court for final approval of the proposed class
19 settlement. The Court has considered all papers filed and proceedings in this matter and held a
20 hearing on September 16, 2011, at which time the parties and all other interested persons were
afforded the opportunity to be heard in support of and in opposition to the proposed settlement.
Based on the papers filed with the Court and presentations made to the Court at the hearing, it
is hereby ORDERED, ADJUDGED, AND DECREED as follows:

1. The definitions and provisions of the Settlement Agreement are hereby
incorporated as though fully set forth herein. For purposes of this Order and Final Judgment,
all capitalized terms used hereafter shall have the meaning ascribed to them in the Agreement,
unless otherwise noted.

1 2. The Court has jurisdiction over the subject matter of the Settlement Agreement
2 with respect to and over all Parties to the Settlement Agreement, including all Settlement Class
3 Members.

4 3. The Court hereby approves the Settlement and finds that the Settlement is, in all
5 respects, fair, reasonable and adequate to the Settlement Class Members, within the authority of
6 the parties, and the result of extensive, arm's length negotiations.

7 4. The Court hereby grants Class Counsel's request for an award of \$430,000 in
8 out-of-pocket costs and attorneys' fees. The fee and costs award, which is in addition to and in
9 no way diminishes the relief provided to the class, is reasonable under the lodestar method
10 preferred by the California courts. *See In re Consumer Privacy Cases, supra*, (2009) 175
11 Cal.App.4th 545, 556–57, 96 Cal.Rptr.3d 127. The Court finds that the time Class Counsel
12 devoted to this case is reasonable. The Court further finds that Class Counsel's rates are
13 reasonable.

14 5. The Incentive awards to Plaintiffs Theron Cooper and Alice Tran are hereby
15 approved in the amount of \$1,500 each, to be paid in accordance with the Agreement. The
16 Court finds such incentive awards to be fair and reasonable in light of the time and effort
17 devoted by Plaintiffs to the prosecution of this litigation on behalf of the Class.

18 6. The Court has considered all timely-filed objections to the Settlement. The
19 Court finds these objections do not counsel against Settlement approval, and they are hereby
20 overruled.

21 7. Pursuant to California Code of Civil Procedure 382 and Civil Code § 1781, the
22 Court certifies, for settlement purposes only, the following Settlement Class:

23 All residents of the United States, Commonwealth of Puerto
24 Rico, U.S. Virgin Islands, Saipan, and Guam who currently own
25 or lease, or previously owned or leased a Class Vehicle. Honda,
26 its officers and directors, Honda's counsel, insurers of Class
27 Vehicles, all entities claiming to be subrogated to the rights of
Class Members, issuers of extended vehicle warranties, and the

1 Judge(s) to whom this Litigation is or has been assigned are
2 specifically excluded from the Settlement Class.

3 8. This Court hereby dismisses this action with prejudice as to all Settlement Class
4 Members except those who have timely and properly excluded themselves from the Settlement
5 Class. Exhibit A, attached hereto, sets forth the names of those individuals who have timely
6 and properly excluded themselves from the Settlement Class.

7 9. Upon the date this Judgment becomes final, Plaintiffs and Settlement Class
8 Members hereby release Defendant from any and all claims or causes of action that were, or
9 could have been, asserted by them, regarding the Class Vehicle's Sun Visors.

10 10. Without limiting the foregoing, the released claims specifically extend to claims
11 that Settlement Class Members do not know or suspect to exist in their favor at the time that the
12 Settlement, and the releases contained therein, becomes effective. The Court finds that
13 Plaintiffs have, and the Settlement Class Members are deemed to have, knowingly waived
14 California Civil Code section 1542 and any other applicable federal or state statute, case law,
15 rule or regulation relating to limitations on releases.

16 11. The Court finds that the program of Class Notice set forth in the Agreement and
17 preliminarily approved by the Court was the best practicable notice under the circumstances.
18 The Class Notice provided due and adequate notice of these proceedings and of the matters set
19 forth therein, including the Settlement Agreement, to all parties entitled to such notice and
20 satisfied the requirements of constitutional due process. The Court specifically finds that this
21 notice complies with the requirements of *In re Mercury Interactive Corp. Sec. Litig.*, 618 F.3d
22 988, 994 (9th Cir. 2010).

23 12. Without affecting the finality of this Settlement Order and Final Judgment in
24 any way, the Court retains continuing jurisdiction over: (a) implementation of the Settlement
25 Agreement and distribution of the settlement relief contemplated by the Settlement Agreement,
26 until all acts agreed to be performed pursuant to the Settlement Agreement have been


1 performed; and (b) all parties to this action and Settlement Class Members for the purpose of
2 enforcing and administering the Settlement Agreement.

3 13. Neither this Order and Final Judgment nor the Settlement Agreement constitutes
4 an admission or concession by any of the released parties of any fault, omission, liability or
5 wrongdoing. This Order and Final Judgment is not a finding of the validity or invalidity of any
6 claims in this action or a determination of any wrongdoing by the defendant. The final
7 approval of the Settlement Agreement does not constitute any opinion, position or
8 determination of this Court, one way or the other, as to the merits of the claims and defenses of
9 Plaintiffs, Honda or the Settlement Class Members.

10 14. In the event that the Settlement Agreement does not become effective in
11 accordance with its terms, then this Order and Final Judgment shall be vacated, the Settlement
12 Class shall be decertified and the Settlement Agreement and all orders entered in connection
13 therewith shall become null and void and of no further force and effect.

14 IT IS SO ORDERED.


